SUBJECT: Resolution 2022-005 Approve a Consumption and Display Permit for Gather on Central LLC

Background:

The applicant, Gather on Central LLC, has submitted an application for a Consumption and Display Permit. This permit type is issued by the Minnesota Department of Public Safety, Alcohol and Gambling Division. The Permit authorizes Gather on Central LLC to allow the consumption and display of alcohol by individuals that are renting space at 206 Central Ave for private parties and events. The applicant will abide by State statutes and City ordinances regarding all requirements and the hours of sale of alcoholic beverages. The Police Department conducted a background check and a review of the Certificate of Liability Insurance by the City Attorney has been completed. Consumption and Display Permits are valid through March 31st of each year.

RESOLUTION #2022-005

APPROVE A CONSUMPTION AND DISPLAY PERMIT FOR GATHER ON CENTRAL LLC

WHEREAS, Gather on Central LLC, applied for a Consumption and Display Permit to be located at 206 Central Ave, in the City of Faribault, consistent with Faribault City Code Chapter 4 and Minnesota Statutes, Chapter 340A; and

WHEREAS, Gather on Central LLC, has paid the required license fees and completed an application packet to request the license; and

WHEREAS, a thorough background investigation by the Faribault Police Department of the associates of Gather on Central LLC was completed, and certified by the Police Chief that the applicants have not been convicted of any violation of any state law or municipal ordinance relating to the sale of intoxicating liquor within the past five years; and

WHEREAS, the city attorney has reviewed and has approved Gather on Central LLC certificate of liquor liability insurance.

WHEREAS, the State of Minnesota Alcohol and Gambling Enforcement Division will be consulted to determine that Gather on Central LLC, can operate as intended by holding a Consumption and Display Permit.

NOW, THEREFORE BE IT RESOLVED, Gather on Central LLC, shall be issued a Consumption and Display Permit, for the term of January 4, 2022 through March 31, 2022.
